SECTION I

INDEPENDENT ACCOUNTANT'S REPORT

REPORT OF THE INDEPENDENT ACCOUNTANT

To the Management of Starfield Technologies, LLC (“Starfield”), a subsidiary of GoDaddy, Inc. (“GoDaddy”):

Scope

We have examined Starfield’s [management assertion](#) that for its Certification Authority (“CA”) operations at its Phoenix, Arizona, USA, and Ashburn, Virginia, USA, locations, for its Starfield and GoDaddy CA certificates as enumerated in Appendix A, Starfield has:

- disclosed its business, key lifecycle management, certificate lifecycle management, and CA environmental control practices within its
 - [Starfield CA Certificate Policy \(CP\) and Certification Practice Statement \(CPS\) v5.01, dated April 1, 2024](#); and
 - [Starfield CA Certificate Policy \(CP\) and Certification Practice Statement \(CPS\) v5.02, dated February 28, 2025](#)
 - [Starfield CA Certificate Policy \(CP\) and Certification Practice Statement \(CPS\) v5.03, dated August 28, 2025](#)
 - [Starfield CA Certificate Policy \(CP\) and Certificate Practice Statement \(CPS\) v5.04, dated September 26, 2025](#)
 - [Starfield CA Certificate Policy \(CP\) and Certificate Practice Statement \(CPS\) v5.05, dated November 28, 2025](#)
- maintained effective controls to provide reasonable assurance that:
 - Starfield provides its services in accordance with its Certificate Policies and Certificate Practice Statements;
- maintained effective controls to provide reasonable assurance that:
 - the integrity of keys and certificates it manages is established and protected throughout their lifecycles;
 - the integrity of subscriber keys and certificates it manages is established and protected throughout their lifecycles;
 - subscriber information is properly authenticated (for the registration activities performed by Starfield); and
 - subordinate CA certificate requests are accurate, authenticated, and approved
- maintained effective controls to provide reasonable assurance that:
 - logical and physical access to CA systems and data is restricted to authorized individuals;
 - the continuity of key and certificate management operations is maintained; and
 - CA systems development, maintenance, and operations are properly authorized and performed to maintain CA systems integrity

throughout the period January 1, 2025 to December 31, 2025, based on the [WebTrust Principles and Criteria for Certification Authorities v2.2.2](#).

Starfield does not escrow its CA keys, does not provide subscriber key generation services, subscriber key storage and recovery services, integrated circuit card lifecycle management, and does not provide certificate suspension services. Accordingly, our examination did not extend to controls that would address those criteria.

Certification Authority's Responsibilities

Starfield's management is responsible for its assertion, including the fairness of its presentation, and the provision of its described services in accordance with the [WebTrust Principles and Criteria for Certification Authorities v2.2.2](#).

Practitioner's Responsibilities

Our responsibility is to express an opinion on Starfield management's assertion based on our examination. Our examination was conducted in accordance with attestation standards established by the American Institute of Certified Public Accountants and in accordance with International Standard on Assurance Engagements 3000, Assurance Engagements Other than Audits or Reviews of Historical Financial Information, issued by the International Auditing and Assurance Standards Board. Those standards require that we plan and perform the examination to obtain reasonable assurance about whether management's assertion is fairly stated, in all material respects. An examination involves performing procedures to obtain evidence about management's assertion. The nature, timing, and extent of the procedures selected depend on our judgment, including an assessment of the risks of material misstatement of management's assertion, whether due to fraud or error. We believe that the evidence we obtained is sufficient and appropriate to provide a reasonable basis for our opinion.

We are required to be independent and to meet our other ethical responsibilities in accordance with the Code of Professional Conduct established by the AICPA and the International Ethics Standards Board for Accountants' Code of Ethics for Professional Accountants.

We applied the Statements on Quality Control Standards established by the AICPA and, accordingly, maintain a comprehensive system of quality control.

The relative effectiveness and significance of specific controls at Starfield and their effect on assessments of control risk for subscribers and relying parties are dependent on their interaction with the controls and other factors present at individual subscriber and relying party locations. Our examination did not extend to controls at individual subscriber and relying party locations and we have not evaluated the effectiveness of such controls.

Inherent Limitations

There are inherent limitations in the effectiveness of any system of internal control, including the possibility of human error and the circumvention of controls. For example, because of their nature, controls may not prevent, or detect unauthorised access to systems and information, or failure to comply with internal and external policies or requirements. Also, the projection to the future of any conclusions based on our findings is subject to the risk that controls may become ineffective.

Opinion

In our opinion management's assertion, as referred to above, is fairly stated, in all material respects.

This report does not include any representation as to the quality of Starfield's services other than its CA operations at its Phoenix, Arizona, USA, and Ashburn, Virginia, USA, locations, nor the suitability of any of Starfield's services for any customer's intended purpose.

Other Matters

Without modifying our opinion, we noted the following other matters during our examination:

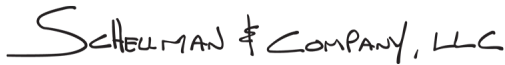
Matter Topic		Matter Description
1	Does Not Provide a Method for Domain Owners to Revoke Their Certificates	Bugzilla #1924992 : On October 16, 2024, GoDaddy was notified that GoDaddy CA (formerly Starfield) did not provide a method for domain owners to revoke their certificates.
2	Delayed CRL File Updates	GoDaddy disclosed in Bugzilla #1949895 that on February 19, 2025, GoDaddy identified an issue which prevented CRL updates from happening as expected. This bug started on February 17, 2025 04:00 UTC and was the result of a server level configuration change. The impact was 7,899 certificate revocations that were not updated on CRL files within 24 hours of their revocation which is a violation of Section 4.9.7 of the Baseline Requirements for the Issuance and Management of Publicly-Trusted TLS Server Certificates which states that “CAs issuing Subscriber Certificates MUST update and publish a new CRL within twenty-four (24) hours after recording a Certificate as revoked.” The issue was limited to CRL updates and was corrected on February 19, 2025 19:01 UTC. Certificate issuance was not impacted. A full incident report was made available on February 28, 2025.
3	Delayed Revocation	Bugzilla #1942877 : On January 21, 2025, GoDaddy received a problem report alerting them to a delayed revocation of 31 certificates reported to have compromised keys due to the Fortinet leak. The compromised certificates were first reported on January 17, 2025, however, the mail address did not accept e-mails with attachments. The user was then contacted by GoDaddy that afternoon requesting the affected keys to be sent to GoDaddy. The certificates and keys were immediately sent to GoDaddy. The following day, three additional certificates and keys were identified and sent to GoDaddy. The certificates were still not revoked as of January 21, 2025, the day the report was submitted.
4	Revocation Process is Unusable Due to Contact Address Not Accepting Attachments	Bugzilla #1942241 : On January 16, 2025, GoDaddy received a problem report alerting them unusable revocation process for reporting a large number of certificates with compromised keys. The compromised keys were first reported in an e-mail with an attachment to ‘practices@starfieldtech.com.’ However, the mail address did not accept mail attachments. Alternate methods for submitting the compromised keys were attempted, including a tarball and a .zip file, however, the same response was received each time indicating that the mail address could not accept the attachment type.
5	Missing R1 Intermediate Full CRL URLs in CCADB	Bugzilla #2002402 : On November 25, 2025, GoDaddy reported that full CRL URLs were missing on the GoDaddy and Starfield R1 intermediate certificate CCADB entries.
6	CA Certificates Published in PEM Format	Bugzilla #2004845 : On December 8, 2025, GoDaddy reported that two CA certificate files referenced in the CA Issuers URI (AIA) of issued certificates were being served in PEM format.
7	CRL Disclosure in CCADB Mismatch with Issued Certificates	Bugzilla #2007216 : On December 19, 2025, GoDaddy reported a mismatch of their CRL files for issuing intermediate certificates on the CCADB and what was listed on the leaf certificates.

Matter Topic		Matter Description
8	Partitioned CRL Files Missing Issuing Distribution Point	Bugzilla #2007217: On December 19, 2025, GoDaddy reported that partitioned CRL files were missing an issuing distribution point.

In addition, our examination identified certain CAs disclosed in the Starfield CP/CPS that were not included in the publicly available repository as required under Control 6.5 of the [WebTrust Principles and Criteria for Certification Authorities v2.2.2](#). Starfield added the certificates to the publicly available repository in August 2025. Additionally, it was determined that the certificates were constrained and Starfield management represented that these roots were never operationalized, did not issue certificates, and had no impact on relying parties or certificate subscribers. During our assessment, Schellman performed testing of certificate issuance, on a sample basis, and noted that there were no certificate issuance deficiencies identified in the samples tested. As a result, our opinion is not modified with respect to these matters.

Starfield's use of the WebTrust for Certification Authorities Seal constitutes a symbolic representation of the contents of this report and it is not intended, nor should it be construed, to update this report or provide any additional assurance.

MANAGEMENT'S ASSERTION

MANAGEMENT'S ASSERTION

Starfield Technologies, LLC ("Starfield") operates the Certification Authority ("CA") services for its Starfield and GoDaddy CA certificates as enumerated in Appendix A, and provides the following CA services

- Subscriber registration
- Certificate renewal
- Certificate rekey
- Certificate issuance
- Certificate distribution
- Certificate revocation
- Certificate validation
- Subordinate CA and cross-certification

The management of Starfield is responsible for establishing and maintaining effective controls over its CA operations, including its CA business practices disclosures on its website, CA business practices management, CA environmental controls, CA key lifecycle management controls, certificate lifecycle management controls, and subordinate CA certificate lifecycle management controls. These controls contain monitoring mechanisms, and actions are taken to correct deficiencies identified.

There are inherent limitations in any controls, including the possibility of human error, and the circumvention or overriding of controls. Accordingly, even effective controls can only provide reasonable assurance with respect to Starfield's Certification Authority operations. Furthermore, because of changes in conditions, the effectiveness of controls may vary over time.

Starfield management has assessed its disclosures of its certificate practices and controls over its CA services. Based on that assessment, in Starfield management's opinion, in providing its CA services at its Phoenix, Arizona, USA, and Ashburn, Virginia, USA, locations, Starfield has:
