## Independent Assurance Report

To the Management of Law Trusted Third Party Services (Pty) Ltd (“LAWtrust-CA”).

### Scope

We have been engaged, in a reasonable assurance engagement, to report on the LAWtrust-CA’s [management assertion](#) that for its Certification Authority (“CA”) operations at its locations as detailed in [Appendix A](#), throughout the period 01 January 2025 to 31 December 2025 for its CA’s as enumerated in [Appendix B](#), LAWtrust-CA has:

- 1 obtaining an understanding of LAWtrust-CA's network and certificate system security to meet the requirements set forth by the CA/Browser Forum;
- 2 testing and evaluating the operating effectiveness of the controls; and
- 3 performing such other procedures as we considered necessary in the circumstances.

We believe that the evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

The relative effectiveness and significance of specific controls at LAWtrust-CA and their effect on assessments of control risk for subscribers and relying parties are dependent on their interaction with the controls, and other factors present at individual subscriber and relying party locations. We have performed no procedures to evaluate the effectiveness of controls at individual subscriber and relying party locations.

### **Inherent limitations**

There are inherent limitations in the effectiveness of any system of internal control, including the possibility of human error and the circumvention of controls. For example, because of their nature, controls may not prevent, or detect unauthorised access to systems and information, or failure to comply with internal and external policies or requirements. Also, the projection to the future of any conclusions based on our findings is subject to the risk that controls may become ineffective.
